For what purposes will we use your personal data?

The personal data we collect from you will be used for the following purposes that are necessary for the service you request: Responding to contact form messages

Description of the purpose of the letter, which may include, but is not limited to, the following: Revocation of consent to process your personal data; and/or Notification of the improper use of the processing of your personal data; and/or Exercise their ARCO Rights, with a clear and precise description of the data to be Accessed, Rectified, Cancelled or Opposed. In the event of rectification of personal data, you must indicate the exact modification and attach the supporting documentation; It is important in the event of revocation of consent, that you bear in mind that in not all cases we will be able to respond to your request or terminate the use immediately, since it is possible that due to some legal obligation we may require you to continue processing your personal data. You should also consider that for certain purposes, the revocation of your consent

will imply that we will no longer be able to provide you with the service you requested, or the termination of your relationship with us.

How many days will we take to respond to your request? 5 days

By what means will we communicate the response to your request? To the same email address from which the request was sent.
